

Sunset Hill Gundog Academy Training Contract

This is a contract between Sunset Hill Gundog Academy (referred to as Sunset Hill) and the dog owner whose signature appears below (referred to as owner). The signing of this contract is a one-time requirement and is activated at each board and train of the owner's dog or dogs.

1. I, the owner, agree to pay the rate for the board and train in effect on the date my dog is checked into Sunset Hill. Total amount of package _____ Monthly payment _____.
2. I further agree to provide feed for my dog, pay all costs for special services requested, and all veterinary costs for my dog while in the care of Sunset Hill. I understand that my dog will not be released to me without payment of services rendered.
3. I understand that despite the best efforts of care and cleanliness at Sunset Hill, certain communicable diseases, especially but not limited to upper respiratory illness may be unavoidable in any multiple animal care facility. I understand that Sunset Hill will make every reasonable attempt to contact me in the event of my dog becoming ill or if the state of my dog's health otherwise requires professional attention. Sunset Hill, in its sole discretion, may engage the services of a veterinarian (including after hour care) or administer medicine or give other requisite attention to my dog, should I be unreachable, and I understand that I will have to pay the expenses.
4. I understand that I must provide paperwork from my veterinarian as proof that my dog has the required vaccines to be boarded at Sunset Hill. I verify that to the best of my knowledge my dog is healthy and free of contagious disease. Should Sunset Hill have reason to question the health of my dog upon presentation, I understand that I may be asked to remove my dog from the facility and produce a health certificate from my veterinarian,
5. Sunset Hill is careful to provide appropriate supervision for all the dogs in their care. However, dogs are prone to rough play and ingesting things they shouldn't, and as a result, injuries can occur. I acknowledge that certain risks of injury in the boarding and training setting do exist and hold Sunset Hill blameless for all injuries resulting from my dog's activities. If my dog is found to be the cause of an aggressive action toward another dog or human, I acknowledge that I am responsible for any veterinary or medical charges resulting from this action. The determination of fault of such actions will be made by the Sunset Hill staff witnessing the event. This determination is final. I further understand that I am responsible for the cost of any legal action resulting from my dog's behavior involving other dogs, humans or

property. I understand that should a dispute of blame arise from any action involving my dog, Sunset Hill reserves the right to release my name, address, phone number and any other pertinent information to those involved, to include but not limited to legal entities.

6. By signing this contract and releasing my dog to the care of Sunset Hill, I certify the accuracy of all information given about my dog. I further agree to be solely responsible for any and all acts of behavior of my dog while it is at Sunset Hill.
7. I specifically represent that I am the sole owner of the dog.
8. If my dog has not been picked up by myself or my representative, and I have not contacted Sunset Hill 14 days after my expected return, Sunset Hill may consider my dog abandoned and will have the authority to place the dog in the protective care of a rescue group or human society. Sunset Hill, will of course, make every attempt to contact me before such action is taken.
9. Whether or not Sunset Hill is addressing a serious behavior problem such as but not limited to aggression, I understand that dog training comes with an inherent risk. I understand that the following statement will hold true regardless of the training venue to include but not limited to my home, Sunset Hill or any off premises training I or Sunset Hill may do with my dog. I will hold Sunset Hill training, trainers, training assistants, trainer apprentices or staff in any way harmless of any blame or fault or any wrongdoing should myself or my dog, family member or any other training participant or observer be injured during the course of evaluation or demonstration of dog training techniques with any Sunset Hill trainer or staff.
10. I understand that the extent to which a dog remains successfully trained is a function of the interest, commitment, consistency and cooperation of the owner upon and after training sessions by Sunset Hill. I acknowledge and agree that there is no guarantee that my dog will retain the desired level of training after being returned to my care
11. Sunset Hill is not responsible for lost or damaged toys, collars, bedding or any miscellaneous items
12. Any controversy or claim arising out of or relating to this contract or the breach thereof or as the result of any claim or controversy involving the alleged negligence by any party to this contract shall be settled by arbitration in accordance with the rules of the American Arbitration Association and judgment. Upon the award rendered by an arbiter shall as a part of this award determine an award to the prevailing party of the costs of such arbitrations and reasonable attorney's fees of the prevailing party.

13. I fully understand and agree to the above conditions and that this agreement shall be activated for each of my dog or dogs in the care of Sunset Hill for every instance of boarding and training provided.

14. I hereby assign and grant to Sunset Hill the right and permission to use, reproduce distribute and publish the photographs, films, videotapes, audio and video recordings, electronic representations and or sound recordings made of me and or my dog at anytime during the training and boarding of my dog by Sunset Hill and I hereby release Sunset Hill from any and all liability resulting from such use, reproduction, distribution and publication

I hereby authorize the reproduction, sale, distribution, copyright, exhibit, broadcast and or electronic storage of any and all such photographs, films, videotapes, audio and video recordings, electronic representations and or sound recordings without limitation at the discretion of Sunset Hill and I specifically waive any right to any compensation I may have for any of the foregoing.
